Keynote Speakers



Lieutenant General (Retired) Charles "Hoop" Hooper is one of the Nation's foremost experts on U.S. security cooperation, security assistance, foreign military sales and the Chinese military, with over 30 years of experience in: security policy formulation and execution; China's military and defense industries; India's defense sector; strategic intelligence; security cooperation; sensitive negotiations; foreign military sales; education and transformational leadership. With operational assignments with the 25th Infantry and 82nd Airborne Divisions, he taught Chinese Foreign Policy at the

Naval Postgraduate School and is a fluent Chinese and Arabic linguist, with a certificate in Chinese Language & Literature from the UK Ministry of Defense Chinese Language School, who served as senior U.S. military officer in China and Egypt, as well as senior DoD strategist and planner for U.S. Africa Command and a senior China policy official, Office of the Secretary of Defense. In his final assignment, Hoop was Director of the Defense Security Cooperation Agency. He is a graduate of the U.S. Military Academy, West Point, the Harvard Kennedy School of Government (MPA), and was a post-graduate research fellow at the Harvard Weatherhead Center for International Affairs. In addition to being a rare American recipient of the French National Defense Medal, he was the first Army student-officer and first Harvard Kennedy School of Government to give a Harvard University graduate student commencement address. Hoop is a member of MENSA and the Council on Foreign Relations.



Lieutenant General Jody J. Daniels recently assumed command as 34th Chief of Army Reserve and 9th Commanding General, U.S. Army Reserve Command – the first woman to lead the Army Reserve. She previously commanded the 88th Readiness Division. During her more than 37 years of active and reserve military service, LTG Daniels has also served as: Chief of Staff, U.S. Forces Command; Assistant Chief of Staff, U.S. Africa Command; Commanding General of the 87th Army Reserve Support Command and Deputy Commanding General, First Army Division East; as

well as other leadership positions, including in Korea, Kosovo and Iraq. LTG Daniels completed Civil Affairs deployments to Kosovo and Iraq, where she served as the Chief of Plans and Integration and later Director for Intelligence for the Multi-National Security Transition Command-Iraq. In her civilian career, she was Director of Advanced Programs for Lockheed Martin's Advanced Technology Laboratories, and has served on the Defense Advanced Research Programs Agency Information Science & Technology Review Board, the ISAT Steering Committee, and Drexel University's Computer Science Department Advisory Board. Daniels holds a Ph.D. in Computer Science from the University of Massachusetts (Amherst) and an M.S. in Strategic Studies from the U.S. Army War College.



Brigadier General Robert S. Cooley, Jr. recently assumed the role as the Army Reserve Chief of Staff, U.S. Army Reserve Command, Fort Bragg, NC, after serving as Commanding General, 353rd Civil Affairs Command. He graduated from the U.S. Military Academy at West Point, NY, and received his Masters' in Business Administration from University of North Carolina - Chapel Hill, and in Strategic Studies from the U.S. Army War College, Carlisle, PA.
